# **Job Description - Building Analyst:**

The initial role of the Building Analyst will be to conduct on-site inspections of residential new construction. ReVireo's technical team will teach the Analyst how to perform inspections, and mentor the Analyst until he or she becomes comfortable conducting inspections unassisted. The Analyst will be expected to conduct quantitative testing, such as measuring HVAC duct leakage and whole-house envelope leakage, as well as record qualitative data, such as identifying and documenting installed insulation, windows, and other construction materials. The Analyst will be moving, loading, and setting up testing equipment (must be able to lift and carry up to 40 lbs.), driving to and from construction sites, and documenting results. The Analyst will learn and utilize basic and intermediate



















construction techniques, building science, energy efficiency terminology, construction timelines, and communication with clients.

After gaining 1-3 years of successful experience conducting inspections, the Analyst will have the opportunity to transition into a consulting role. The Analyst will utilize software to ensure that clients meet their project requirements and goals, such as energy code compliance, high-performance certification programs, maximizing financial incentives, or minimizing costs. ReVireo's team of consultants will teach the Analyst how to utilize the relevant software and how to communicate with clients.

## **Initial Responsibilities:**

- Obtain the HERS Rater certification by successfully passing the HERS Rater exam and completing initial training materials (exam and training fees covered by ReVireo)
- Learn the inspection equipment, procedures, and documents
- Conduct on-site construction inspections
  - Assist a lead inspector (first 12-16 weeks)
  - Conduct inspections unassisted (target 3-4 months after date of hire)
- Record inspection results accurately and submit results to Inspection Manager
- Communicate results with construction managers and/or clients

### **Responsibilities (in transition to Consultant Role)**

- Learn how to use energy modeling software
- Consult with clients regarding construction specifications necessary or recommended to achieve compliance with energy code requirements and/or energy efficiency certifications
- Represent ReVireo at trade shows, networking events, and other meetings
- Educate and train builders and subcontractors on energy code requirements, certification program requirements, and best-practice techniques for energyefficient construction



















# **Position Requirements:**

There are no minimum experience or certification requirements for this position, but preference will be given to applicants with any of the following:

- Education in any of the following fields of study: mechanical engineering, civil engineering, engineering technology, construction management, environmental science, sustainability
- Experience in the construction industry; in particular, construction management, HVAC, and/or air-sealing
- Experience with construction drawings, such as take-offs or estimation
